Speaker Bios



Raffi Freedman-Gurspan (she/her) is the Principal Deputy Director of Public Engagement at the United States Department of Transportation. She was previously a Deputy States Director for the All on The Line campaign of the National Redistricting Action Fund and oversaw work in the Midwest and East Coast. Raffi also has extensive experience in LGBTQI+ and gender justice community advocacy.

Her experience includes serving as Director of External Relations at the National Center for Transgender Equality (NCTE) and Senior Associate Director for Public Engagement, and Outreach and Recruitment Director for Presidential Personnel at the White House during the Obama Administration, where she was the first openly transgender staffer

in history to work at the White House. A graduate of St. Olaf College in Minnesota, Raffi was adopted from Honduras and grew up in Brookline, Massachusetts.



The Honorable Vincent Logan (he/him) was appointed to the FCA board by President Joseph Biden on October 3, 2022. He was designated board chairman and CEO on October 21. Chairman Logan is the first openly gay person to serve on the FCA board; as a member of the Osage Nation, he is also the first Native American. He is serving a term that expires on May 21, 2026.

Chairman Logan is also a member of the board of directors of the Farm Credit System Insurance Corporation, an independent U.S. government-controlled corporation that insures the timely payment of principal and interest on obligations issued jointly by Farm Credit System banks.

Prior to joining FCA, Chairman Logan was chief financial officer and chief investment officer for the Native American Agriculture Fund, which is the largest philanthropic organization dedicated solely to serving the Native American farming and ranching community.

Nominated by President Barack Obama and confirmed by the U.S. Senate in 2014, Chairman Logan served as the Special Trustee for American Indians at the U.S. Department of the Interior. During his tenure, he was appointed to the Department of the Treasury's Financial Literacy Education Commission.

Chairman Logan has worked in New York both as a lawyer, practicing in aircraft, shipping, and equipment finance, and as an investment advisor, focusing on institutional asset management and permanent fund development.

Chairman Logan previously served as a director to the Federal Reserve Bank of St. Louis, Little Rock Branch, and as an Oklahoma State University Foundation governor. He was educated at Oklahoma State University; the University of Oklahoma College of Law; Queen's College, Oxford University; and the School of International and Public Affairs at Columbia University.

Jeremy has been a part of the USDA family for over 23 years and works in the Office of the Chief Diversity and Inclusion Officer, Office of the Secretary. Jeremy has worked in Civil Rights/Affirmative employment at several USDA Agencies and been involved with the LGBTQ+ Special Emphasis Program since its creation in 2009.

Jeremy is currently serving as the President of Equality USDA, the LGBTQI+ Employee Resource Group and has been a leader in establishing LGBTQI+ inclusive policies that help make USDA welcoming workplace.

Joshua "Josh" Allen was born and raised in Lake Charles, LA. Joshua, received their Bachelor of Science in Agriculture with a concentration in Agronomy from Prairie View A&M University, Prairie View, TX. They began their career as a Biology Teacher/ Events Coordinator with P.U.S.H. Academy in Denver, CO working with High School Seniors to prepare for next steps in their academic or occupational journey. In 2015, Josh shifted their career trajectory serving as a Soil Conservationist, and Outreach Coordinator with NRCS in TX and VT, where he also served as the LGBTQI+ SEPM. Currently, Joshua serves as the national LGBTQI+ and Disability SEPM with the Civil Rights & EEO Division on the Title VII Team in the FPAC Business Center. In their spare time, Josh loves long hikes with their dog Blu, swimming, cookouts, gymnastics workouts and building community! Additionally, Josh is a musician and plays guitar, piano, saxophone, in addition to singing, writing, and producing music.

Notes

Equality USDA uses the acronym LGBTQI+ to represent the range of sexual orientations, gender identities, and gender expressions present in our world, including but not limited to lesbian, gay, bisexual, transgender, queer, questioning, pansexual, Two Spirit, gender nonconforming, nonbinary, intersex, asexual, and ally.

EEO

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, religion, sex, gender identity (including gender expression), sexual orientation, disability, age, marital status, family/parental status, income derived from a public assistance program, political beliefs, or reprisal or retaliation for prior civil rights activity, in any program or activity conducted or funded by USDA (not all bases apply to all programs). Remedies and complaint filing deadlines vary by program or incident.

Persons with disabilities who require alternative means of communication for program information (e.g., Braille, large print, audiotape, American Sign Language, etc.) should contact the responsible Agency or USDA's TARGET Center at (202) 720-2600 (voice and TTY) or contact USDA through the Federal Relay Service at (800) 877-8339.
